<u>Minutes:</u> Councilor Kirkland offered a motion to waive the reading of and approve the minutes from June 19, 2025. Councilor Sanders duly seconded the motion. Mayor Pro-Tem Churchwell called for all in favor say 'aye', all opposed say 'no'. Mayor Pro-Tem Churchwell, "Let the record reflect the 'ayes' carry unanimously".

<u>Finance:</u> Councilor Irvin offered a motion to approve the bills in the amount of \$44,259.57. Councilor Walker duly seconded the motion. Mayor Pro-Tem called for all in favor say 'aye', all opposed say 'no'. Mayor Pro-Tem, "Let the record reflect the 'ayes' carry unanimously".

<u>New Business:</u> Councilor Sanders offered a resolution electing the office of Councilor Place 2 without opposition, Brad Walker. Councilor Kirkland duly seconded the motion. Mayor Pro-Tem Churchwell called for all in favor say 'aye', all opposed say 'no'. Mayor Pro-Tem Churchwell, "Let the resolution passed unanimously as Resolution 25-13".

Councilor Walker offered a resolution election Councilor Place 4 without opposition, Paula Sims. Councilor Kirkland duly seconded the motion. Mayor Pro-Tem Churchwell called for all in favor say 'aye', all opposed say 'no'. Mayor Pro-Tem Churchwell, "Let the record reflect the resolution passed unanimously as Resolution 25-14".

Councilor Irvin offered a resolution to appoint the City Clerk to perform the duties for holding a municipal election as required by law. Councilor Kirkland duly seconded the motion. Mayor Pro-Tem Churchwell called for all in favor say 'aye', all opposed say 'no'. Mayor Pro-Tem Churchwell, "Let the record reflect the resolution passed unanimously as Resolution 25-15".

Public Comment:

Kelli Warr, 4504 Bud Holmes Road. Ms. Warr asked about the flooding due to Beaver Dams behind her home. Councilor Sanders explained that property is owned by U.S. Fish and Wildlife but the local Landtrust has received a permit to begin removing the dams.

Tracie Thompson, 6408 Sunrise Lane. Ms. Thompson asked if the city was in communication with ALDOT regarding the maintenance of the Highway 75 side affected by the flooding. Councilor Sanders stated Fish & Wildlife, a Federal office, are the owners, Landtrust helps to maintain area.

Dorlan Terry, 5455 Miles Spring Road. Stated there had been criticism on Facebook about the candidates running for the municipal election and the placement of their political signs. Mr. Terry stated he was the person that put the signs out, not the candidates.

James Vining, 6803 Marcum Drive, Trussville, AL. Mr. Vining stated he was the one that made the post on Facebook about the signs and he felt the city should be held accountable the same as other citizens regarding placement of signs.

Councilor Sanders offered a motion to adjourn the meeting. Councilor Walker duly seconded the motion. Mayor Pro-Tem Churchwell called for all in favor say 'aye', all opposed say 'no'.
